Engagement of Contractual Teachers is subject to following Terms & Conditions:-

A) General Conditions:-

- 1. The services of contractual teacher shall be utilized on day to day basis depending upon the need which may vary on day to day basis subject to availability of funds. The services may be terminated at any time without assigning any reason.
- **2.** Contractual Teacher shall not be entitled to regular appointment. The candidates so engaged shall not claim salary, allowances, facilities and other benefits accruing to the regular teachers.
- **3.** Contractual teacher neither claim regularisation in the services nor claim appointment as a teacher in Kendriya Vidyalaya Sangathan.
- **4.** She/he would be engaged till such time the regular teacher joins or the end of the academic session or relieved by Vidyalaya, whichever is earlier.
- The candidate should posses the required educational qualification as prescribed by Kendriya Vidyalaya Sangathan for direct recruitment to the post.

B) Service Conditions:-

1. Teachers engaged on contractual basis, would have no claim or right for appointment on a regular basis nor will they be a part of the cadre of teachers of Kendriya Vidyalaya Sangathan.

- 2. Teachers appointed on contractual basis will not be entitled for vacation pay and during Autumn/Winter Break payment shall be calculated on pro rata basis.
- **3.** Teacher will not be entitled for pay, if remains absent on working day. In case of absence from duty(with prior permission of competent authority) payment will be calculated on pro rata basis.
- 4. Working hours shall be same as of regular teacher.

C) Duties & Responsibilities of Contractual Teachers:-

- 1. Regular classroom activity/copy checking.
- **2.** Invigilator duty/evaluation work.
- **3.** Helping students and colleagues in preparation and organization of different curricular / cocurricular activities in the Vidyalaya.
- 4. All other works assigned by the principal.

F) Special Provision:-

- 1. Relaxation of B.Ed/B.Eld Qualification:- In the absence of suitable candidates with B.Ed. Degree in Hard station and in remote areas of North-East candidates with following qualifications may be considered in different categories without B.Ed. qualification
 - a) Post Graduate with 60% marks in Science subjects and 55% in Humanities subjects may be considered for the posts of PGTs, if suitable candidates with B.Ed. are not available.
 - **b**) Similarly B.Sc. with 60% marks and BA with 55% marks may be considered for the posts of TGTs, if suitable candidates with B.Ed. are not available.
 - c) Graduates may be considered for the post of Primary Teacher if candidates with Senior Secondary/Plus 2/Inter with D.Eld / JBT / ETT / B.Eld . qualification are not available.
- 2. Relaxation in CTET:- In the absence of CTET qualified candidate, candidate without CTET qualification may be considered if otherwise eligible as per Kendriya Vidyalaya Sangathan recruitment rules.

G) Age Limit: As on 01 March 2023

Minimum and Maximum age limit shall be 18 and 65 years respectively.
